EDUCATOR'S CONVENTION CONTRACT

I hereby make application to demonstrate at the convention held on August 14-19, 2017, at Greater Columbus Convention Center, 400 North High St., Columbus, Ohio. In keeping with this contract, **I will abide by the following rules and regulations:**

1. **The projects submitted must not be offered to any other convention, seminar, magazine, website, e-magazine, e-club or publication in the 2017 calendar year.** By signing this contract, the Educator gives Heart of Ohio Tole Chapter, Inc., permission to publish the class picture and information on HOOT's website and in the convention catalog.
2. Projects submitted may be 2, 4, 6, or 8 hour classes. The majority of students should complete the project within the class time frame. Please note that the 2-hour specials have been eliminated
3. The class surface fee listed on the PROJECT DATA SHEET will be published in our convention catalog and may not be changed. The Educator will provide 2 glossy, high-quality COLOR photographs (size 4" x 6") with a Project Data Sheet for each project submitted. **NO photocopies, black and white, or oversized photographs will be accepted.**
4. Educators agree to **accept up to 35 students per class.** Educators will remain in the classroom for the full class time unless all the students have completed their projects and left the room.
5. It is the responsibility of the Educator to provide each student with a base-coated painting surface, paint, mediums, pattern, written instructions, and one (1) color photograph of the project being taught. All items shown in the project photo must be included in the cost of the project unless otherwise noted on the Project Data Sheet. Educators must provide 1 complete pattern, instruction packet and color photo of each class selected for the HOOT library. This must be submitted **at the convention** when the Educator registers or by the end of the day of the class.
6. **Educators may not use the class period for selling or promoting anything that does not pertain to the current class project including seminars, books, products, etc.** Educators may not permit any other person to sell, promote or announce seminars, books, products, etc., during the class.
7. Educators will be paid based on the following scale per registered student: 2 hr. = \$10.00; 4 hr. = \$15.00; 6 hr. = \$20.00; 8 hr. = \$25.00. Educators will not pay the convention registration fee unless they take classes. A banquet ticket will be provided to each educator.
8. **Class Cancellation Policy:** Any class that is less than 25% filled (nine or fewer students) by June 2, 2017, may be cancelled by Heart of Ohio Tole Chapter, Inc., and/or the Educator. If an educator wishes to cancel a class after July 2, 2017, that cancellation will be subject to a penalty equal to the current class fees due Heart of Ohio Tole Chapter, Inc., based on the number of registered students for the class. Penalty may be waived with proof of extenuating circumstances which will be considered by the Board of Directors.
9. Educators are responsible for the collection and payment of all State of Ohio taxes and must obtain a transient vendor's license.
If it is necessary for you, the educator, to reduce the number of students to fewer than 35, you MUST confirm that fact in writing by July 7, 2017, come prepared for 35 students or be prepared to pay a penalty of 10% of the class fees of the difference between the number of students signed up for the class and 35 for breach of contract.
